FIGURE 1 – FRONT / RIGHT SIDE VIEW

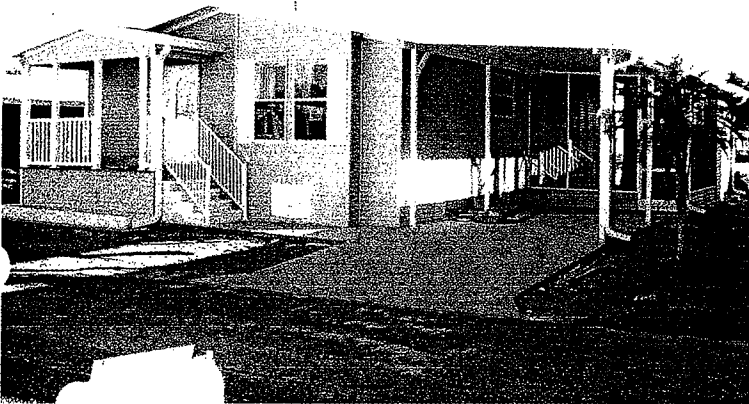


FIGURE 2 – REAR / LEFT SIDE VIEW
