WHEREAS, the legislature of the State of Florida enacted the Community Redevelopment Act of 1969, which is presently codified in Chapter 163, Part III, Florida Statutes, as amended (hereinafter referred to as the "Act"); and

WHEREAS, the Board adopted Sarasota County Resolution No. 98-122, on May 26, 1998 declaring itself to be the Sarasota County Community Redevelopment Agency (the Agency) with the provisions that the Agency may utilize advisory boards for each adopted CRA; and

WHEREAS, the Board adopted Sarasota County Resolution No. 98-123 on May 26, 1998, establishing the Englewood Community Redevelopment Area (CRA) Advisory Board; and

WHEREAS, the Board adopted Sarasota County Resolution No. 99-310 on December 14, 1999, approving the Englewood Redevelopment Plan; and

WHEREAS, the Englewood Redevelopment Plan has been previously modified on April 24, 2001, February 24, 2004, March 16, 2005 and October 25, 2005; and

WHEREAS, it is necessary and in the public interest to further modify said Englewood Redevelopment Plan to incorporate changes in the projects and the project budget to achieve the purposes of the Plan; and

WHEREAS, the Englewood CRA Advisory Board recommended the modifications to the Englewood Redevelopment Plan to the Agency; and

WHEREAS, the Agency, reviewed and recommended to the Sarasota County Board of County Commissioners approval of the Amended Englewood Redevelopment Plan to include a Stormwater Project on November 15, 2006.

NOW, THEREFORE, BE IT RESOLVED BY THE SARASOTA COUNTY BOARD OF COUNTY COMMISSIONERS, SARASOTA, FLORIDA

R2006-245

1. That Englewood Redevelopment Plan be amended by the addition of a new project for the design, property acquisition and construction of Stormwater improvements in the business district, identified in the Plan as project #24 – Stormwater Project.

2. If any provision of this Resolution is for any reason finally held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining provisions.

3. This Resolution shall become effective immediately upon its adoption.
