Dear Planning and Development Services Staff,

This letter and attached application form are a request for mailing labels in conjunction with a proposed Rezone Petition on a .41 acre +/- and .37 acre +/- parcel located north of Clark Road and east and west of Lambert Place in Unincorporated Sarasota, Florida. The two parcels are under unified ownership and are located at 5777 Lambert Place and 3866 Clover Lane, Sarasota, Florida 34233. The Parcel Identification Nos. are 0090140014 and 0090140017.

The subject parcels are both currently zoned RSF-3 (Residential Single Family, 4.5 dwelling unit per acre) and are currently designated on the County's Future Land Use Plan Map as Commercial Corridor. The subject parcels are currently developed with two single family homes. The Applicant is proposing a Rezoning from RSF-3 to OPI (Office Professional and Institutional) requiring the removal of the two existing homes and replacement with two modern office buildings of 2,000 Sq. Ft respectively.

My client is Mr. Tom Elliot, Owner of the two properties and Owner of the Paddy Wagon Tavern located on the adjacent parcel at 3877 Clark Road. Mr. Elliot is proposing the Rezoning in order to allow the construction of an office building to serve his company operating under TR Big's LLC and other small office users. Through the Rezone Petition, the Applicant intends on addressing the appropriateness of developing two office buildings under the OPI zoning within a designated Commercial Corridor which will serve as a step down in land use intensity between the more intensive CG (Commercial General) zoned properties along Clark Road and the existing single family homes to the north.

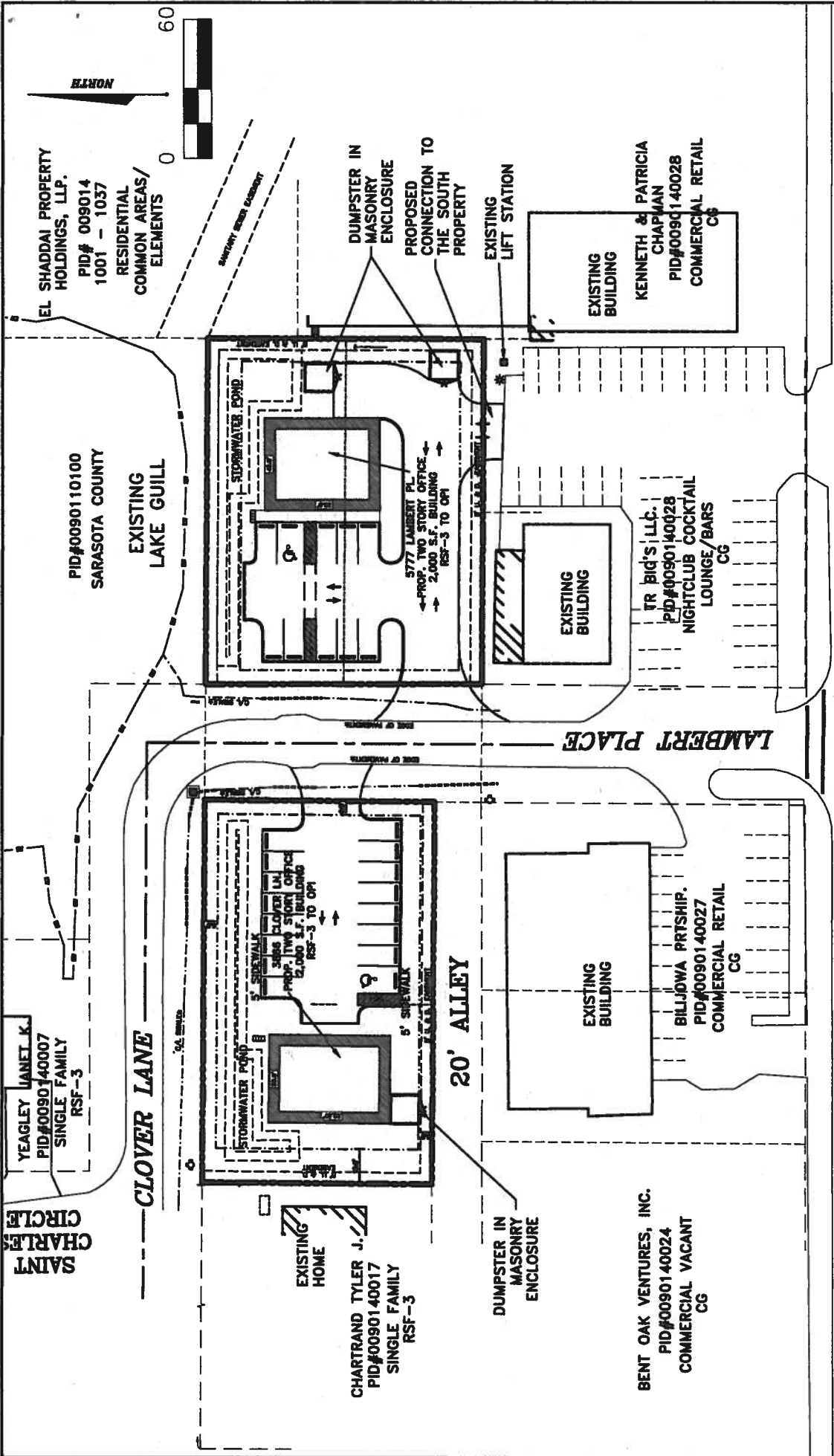

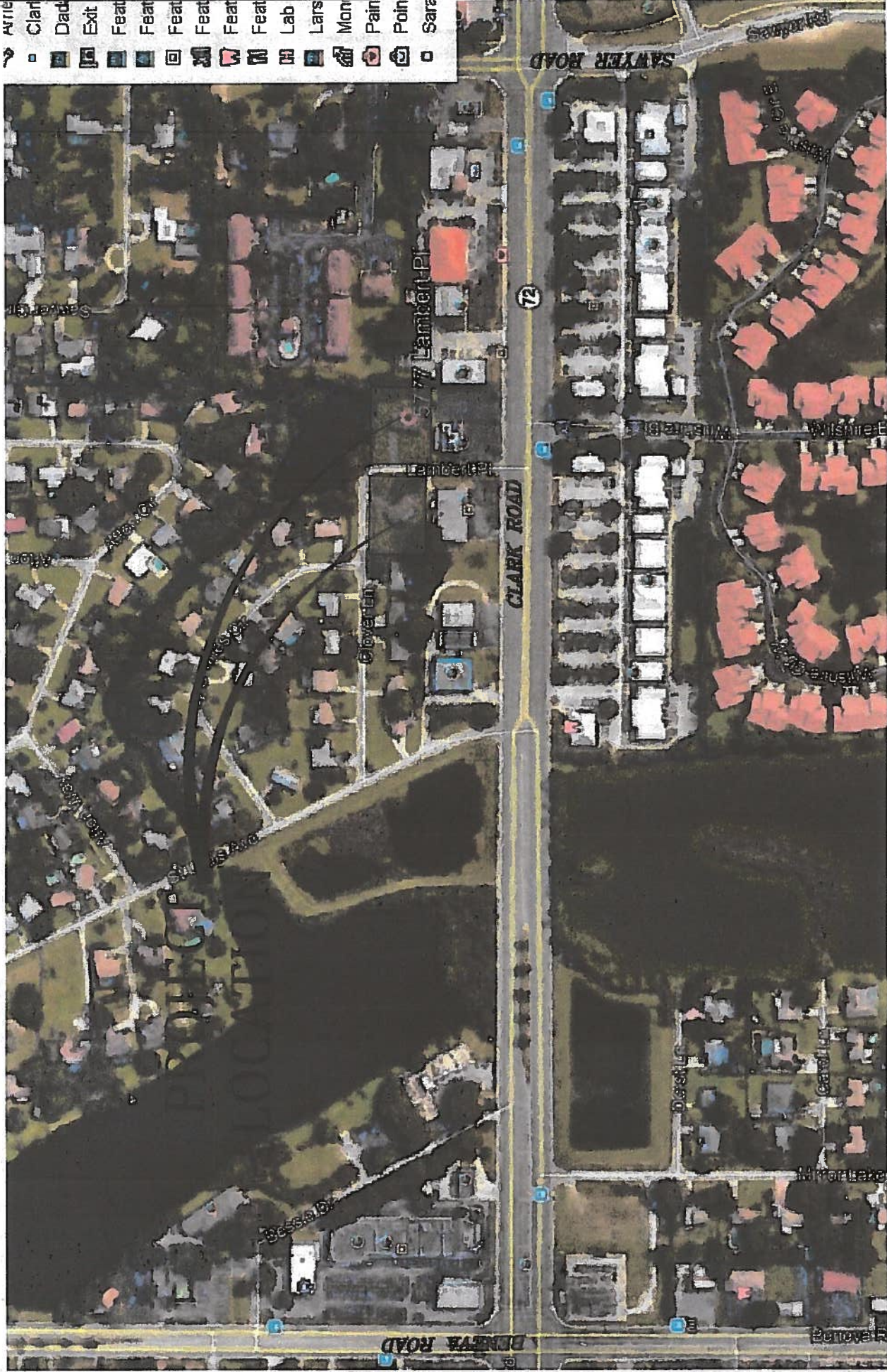

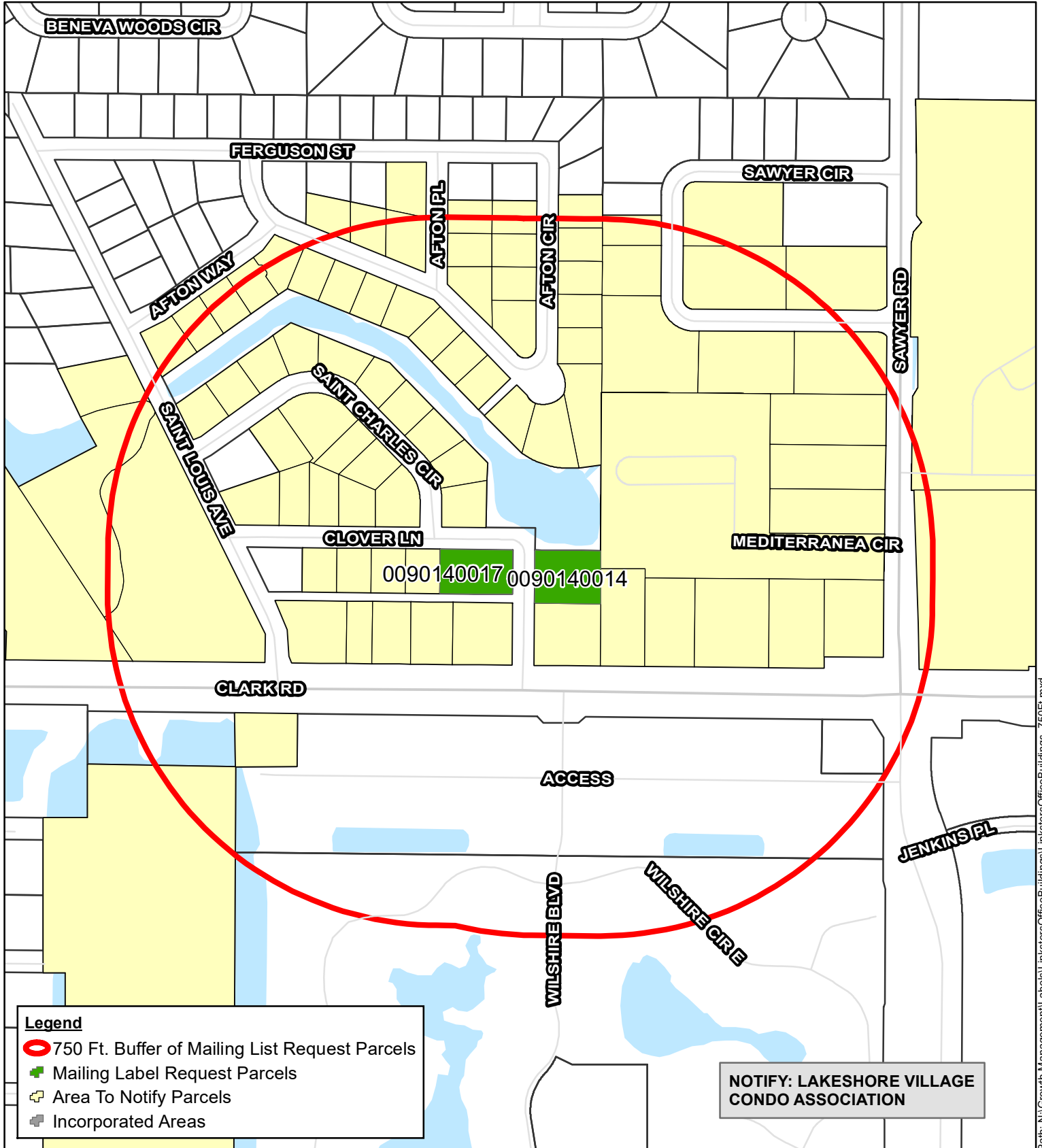
